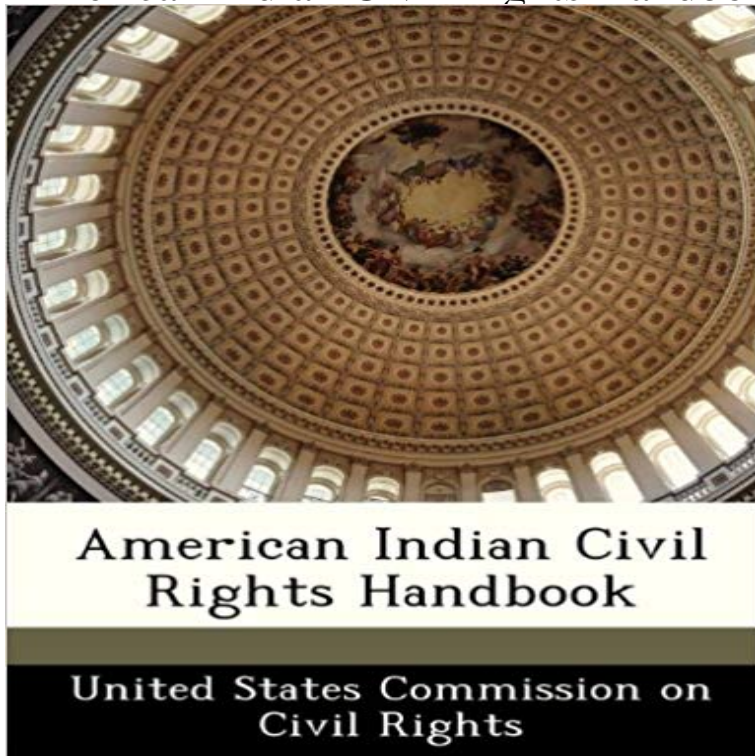


American Indian Civil Rights Handbook
