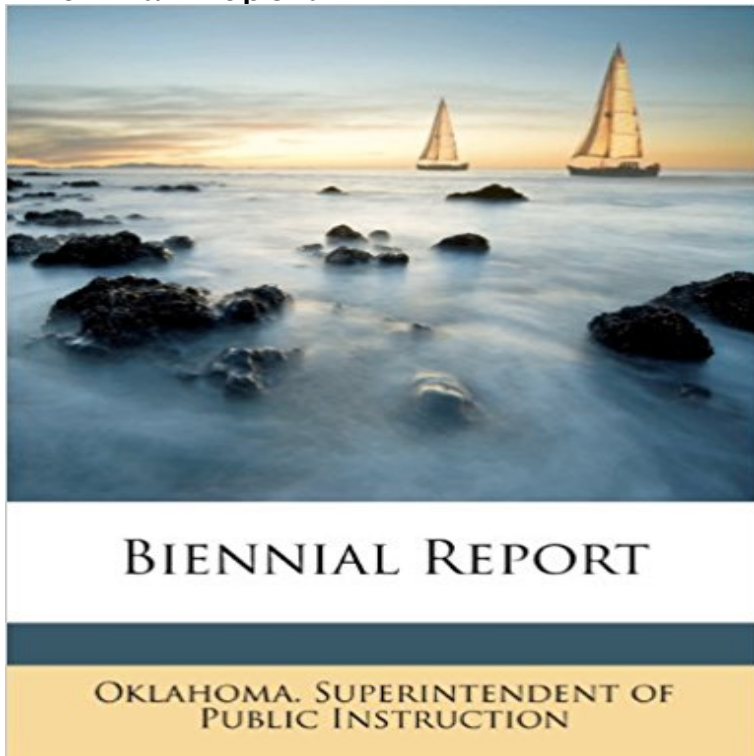

However, failure to comply with Federal and State regulations regarding Annual/Biennial reports may result in **Biennial Hazardous Waste Report Hazardous Waste Generators** Federal regulations require large quantity generators to submit a report every two years regarding the nature, quantities and disposition of hazardous waste generated at their facility.
