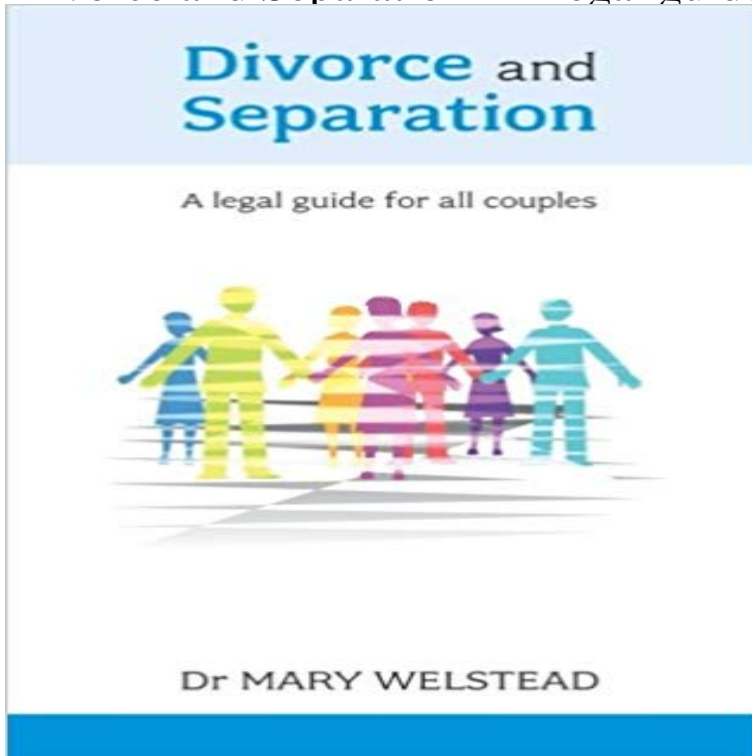


Divorce and Separation - A legal guide for all couples
