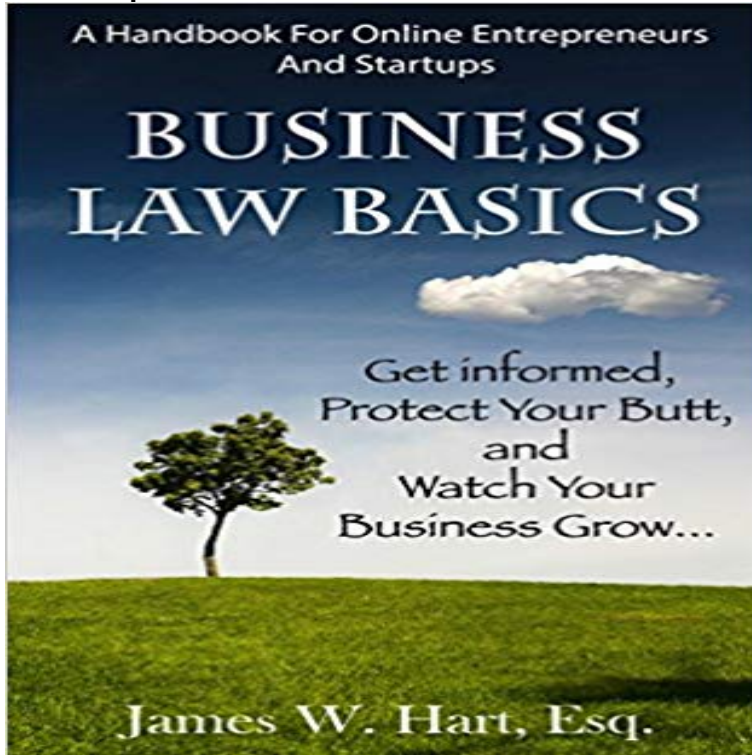


Business Law Basics: A Legal Handbook for Online Entrepreneurs and Startup Businesses
