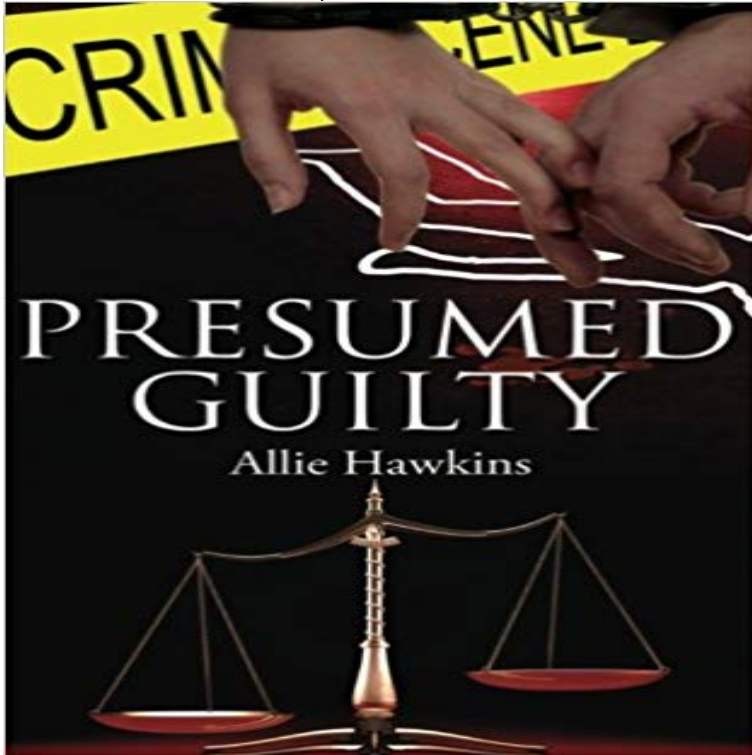


Presumed Guilty
