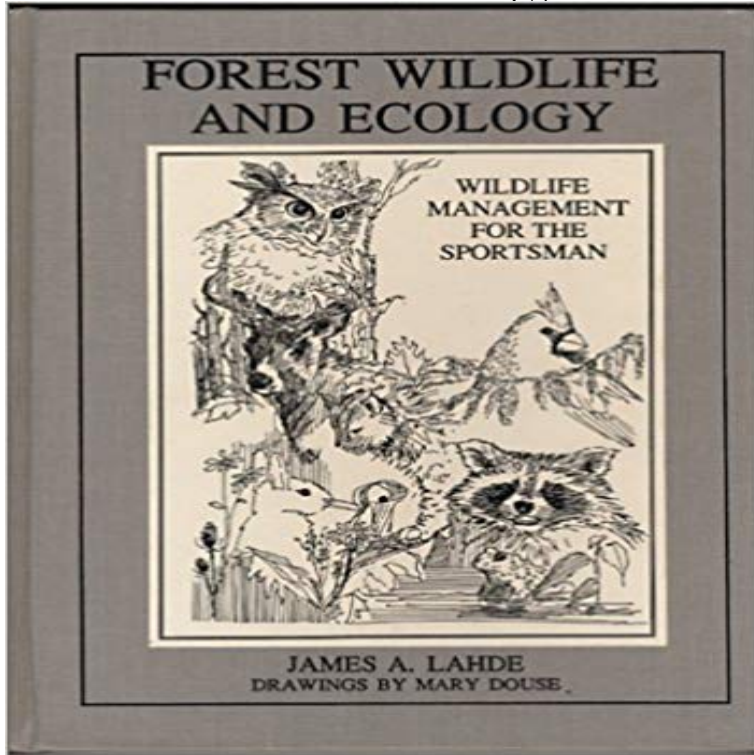


Forest Wildlife and Ecology: Wildlife Management for the Sportsman
