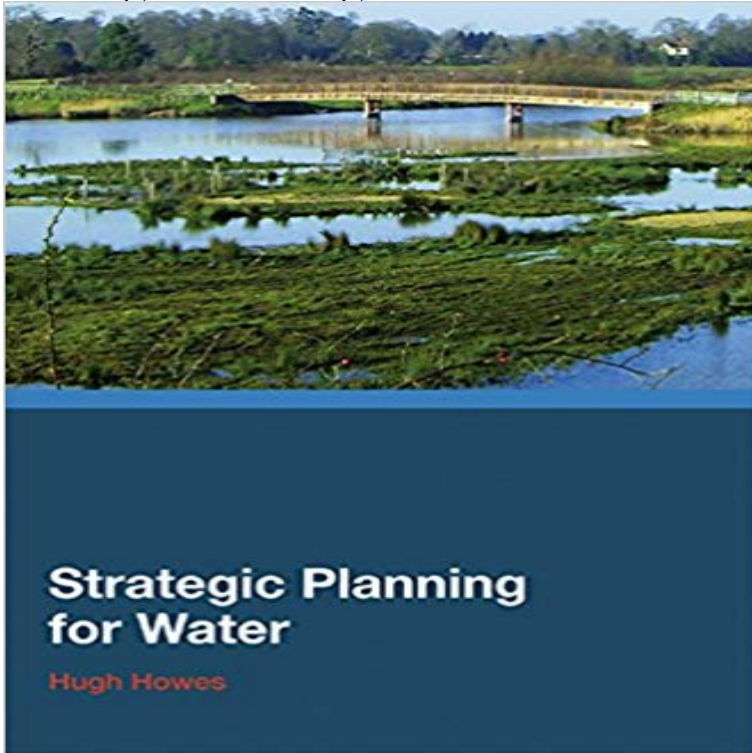


Strategic Planning for Water
